

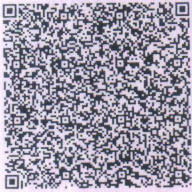



Validity:

This Memorandum of Understanding will be valid for a period of three years. This Memorandum of Understanding shall come into effect from (Date) *08th July 2019.*


